1. Print the Powerco Membership Signature Card below and provide all information requested. Please note the Membership Signature Card must be completed in its entirety, including a complete address for your nearest relative.
2. Sign and date the bottom of the signature card.
3. If a joint account is desired (optional), obtain signatures on Joint Membership Agreement. You will sign as "Applicant" and all Joint Owner(s) will sign beneath your signature.
4. Provide a copy of photo identification for you and each person listed on the account. Types of acceptable identification are: Driver's License, Military ID, or State ID; copy of Social Security Card for minors.
5. A \$5 minimum deposit is required to open your Share Savings Account and establish membership with Powerco Federal Credit Union.
6. Visit any branch office (a list of branch locations is available on our website) or mail your signature card, copy of your photo identification and deposit to Powerco Federal Credit Union, 241 Ralph McGill Boulevard, NE, Atlanta, GA 30308.

# USA Patriot Act Notification

## Important information Concerning Procedures for Opening a New Account at Powerco Federal Credit Union

To help the government fight the funding of terrorism and money laundering activities, Federal law (Section 326) requires all financial institutions to obtain, verify and record information that identifies each person who opens an account. We will ask for your name, address, date of birth and other information that will allow us to identify you and all listed on your account. A photocopy of picture identification for yourself and any other persons who will be listed on your account may be obtained. Acceptable forms of picture identification include your state issued driver's license, military identification card, state identification card, etc.

If you are an existing member who joined the credit union before the USA Patriot Act rules became effective, October 26, 2001, we may also need to verify and retain copies of any documents used to verify your identity when you request a new deposit account, apply for a loan or are added as a signatory to a new or existing deposit or loan account.

If, for any reason, you are unable to provide the information necessary to verify your identity, the account(s) may not be opened; or the account(s) may be blocked or closed, which may result in additional fees assessed to the account(s).
